**Fair Requirements:**

1. Market sheep must be born **on or after** January 1<sup>st</sup> of the current year.
2. Registration forms with missing or incomplete information **will not** be accepted and the 4-Her's **will not** be allowed to show Market Sheep at fair.
3. All sheep going through the livestock sale or in carcass class are **required** to have a Scrapies identification tag.
4. **A County ear tag is required for identification. These tags are issued by livestock committee. Each tag will cost \$1. All unused tags **MUST** be return before weigh in at fair.**
5. Each member may register up to three (3) market sheep and each family may declare one (1) family floater. The family floater animal may be registered by more than one (1) immediate family member, but can be shown by only one (1) family member.
6. **Forms can be mail, email (addresses listed below) or drop off at the Fairground office on May 1, 2018 by 4pm.**
