Fair Requirements:

- 1. All information **must be complete** to show swine at the Montcalm County 4-H Fair, as this information is reported to the Michigan Department of Agriculture and Rural Development office.
- 2. It is recommended that Market swine be born on or after December 1st of the prior year of fair.
- 3. PQA Certification is **required** to sell swine at the Montcalm County 4-H Fair.
- 4. **NEW** A Michigan Department of Agriculture and Rural Development Ear Tag is required for identification. These tags are issued by Livestock Committee. Each tag will cost \$1. All unused tags MUST be return before weigh in at fair.
- 5. Each member may register up to three (3) market swine and each <u>family</u> may declare <u>one</u> (1) family floater. The family floater animal may be registered by more than one (1) immediate family member, but can be shown by only one (1) family member.
- 6. Forms can be mail, email (addresses listed below) or drop off at the Fairground office on May 1, 2018 by 4pm.
