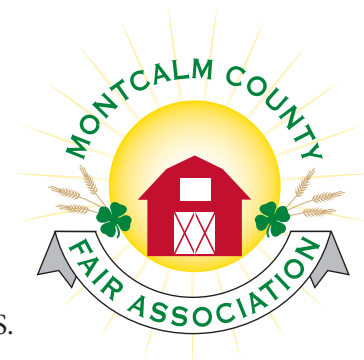


MONTCALM COUNTY FAIRGROUNDS CAMPING RULES & REGULATIONS AND 4-H REGISTRATION FORM



Rules & Regulations

1. Anyone camping on the fairgrounds must also follow GENERAL RULES & REGULATIONS.
2. At least one (1) adult chaperon (ages 21 & over) must stay in each campsite every night.
3. Vacuum Breakers must be properly installed on every unit & NO "Y"s connected to water supply.
4. Absolutely NO drainage of wastewater on the grounds. It must be dumped at the dump station.
5. Campers are responsible to take their garbage to dumpsters & NO generators between 11 p.m. and 6 a.m.
6. All campers must park on their own campsite. Fire Lane & Roadway must be clear at all times or vehicle will be towed at owner's expense.
7. Extension cords plugged into camper MUST be same weight/gauge as camper cord & supply own pigtails.
8. No campfires allowed in the campground.
9. Use of motorized vehicles:
 - a.) No unlicensed drivers will be allowed to operate a vehicle on Fairgrounds. Excessive Speed (over 15mph), careless driving, driving on the midway, driving that endangers the operator, occupants, or the public will receive a warning. Anyone who has been warned of improper use of their vehicle more than one time will be required to surrender their identification form and must park their vehicle.
 - b.) Facilities Manager and the local law enforcement personnel are authorized to enforce and administer the above rules.

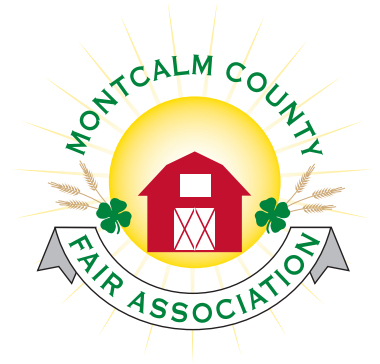
